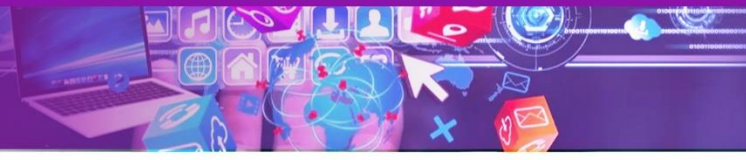

Cuba bunuh diri selepas tikam teman wanita

Mangsa maut ditikam 18 kali, leher dikelar

Petaling Jaya: Penahanan seorang lelaki warga asing yang dipercayai cuba membunuh diri di landasan Express Rail Link (ERL) Salak Selatan, Sabtu lalu, membongkar satu kes pembunuhan dilakukannya di sebuah kondominium di Kelana Jaya, di sini, sehari sebelum itu.

Serbuan ke atas kondominium itu menemui mayat wanita terbaring dalam sebuah bilik dengan kesan 18 tikaman di beberapa bahagian badan, selain leher dikelar.

Ketua Polis Petaling Jaya, Asisten Komisioner Mohamad Fakhruddin Abdul Hamid, berkata suspek lelaki berusia 30 tahun itu ditahan

polis bantuan di stesen ERL terbabit pada kira-kira jam 4.50 petang, sebelum diserahkan kepada pihak Ibu Pejabat Polis Daerah (IPD) Cheras, Kuala Lumpur.

Beliau berkata, suspek cuba membunuh diri dengan meletakkan separuh badan di atas landasan, namun gagal selepas ERL yang datang tidak melalui landasan itu, sebaliknya di landasan bersebelahan.

"Hasil soal siasat Polis Daerah Cheras, suspek mengaku mahu membunuh diri selepas membunuh

teman wanitanya di sebuah kondominium di Kelana Jaya, di sini.

"Sepasukan anggota dari Bahagian Siasatan Jenayah (BSJ) IPD Cheras dan IPD Petaling Jaya kemudian menyerbu kondominium terbabit dan menemui mayat mangsa dalam keadaan terbaring dalam sebuah bilik," katanya pada sidang media, di sini semalam.

Mohamad Fakhruddin berkata, pemeriksaan mendapati mangsa ditikam 18 kali di beberapa bahagian badan dengan sebilah pisau pemotong buah, selain leher dikelar.

"Pembunuhan dipercayai berlaku antara jam 4 hingga 6 petang Jumaat lalu (sehari sebelum suspek cuba membunuh diri) dan pembunuhan bermotifkan cemburu.

"Suspek dan mangsa berusia 40 tahun baru datang dari India tiga bulan lalu dan kedua-duanya sedang menjalin hubungan sulit dari negara asal kerana mangsa mempunyai suami dan anak di India," katanya.

Polis tahan tujuh individu

Mohamad Fakhruddin berkata, dalam serbuan itu, polis turut menahan tujuh individu membabitkan lima lelaki warga asing, seorang lelaki tempatan dan seorang wanita warga asing yang mendiami unit kondominium terbabit bersama suspek serta mangsa.

Beliau berkata, pada hari kejadian, suspek mengesyaki mangsa mempunyai hubungan sulit lain dengan seorang daripada rakan serumah mereka, menyebabkan suspek berang dan membunuh mangsa.

Lelaki kasari pemandu wanita dipenjara 7 hari

Penyelia kilang mengaku salah pukul kepala, ugut mangsa

Tapah: Mahkamah Majistret Tapah di sini, semalam, menjatuhkan hukuman tujuh hari penjara ke atas lelaki yang mengasari pemandu wanita di Lata Iskandar, Isnin lalu.

Majistret Siti Hanum Mohamad Sah menjatuhkan hukuman itu terhadap penyelia kilang, Mohammad Zaim Faiz Tarmizi, 29, selepas dia mengaku bersalah atas dua pertuduhan mencederakan dan mengugut pemandu wanita terbabit dalam insiden yang tular di media sosial.

Mengikut kertas pertuduhan, Mohamad Zaim didapati menamatkan secara jenayah terhadap mangsa, Amiera Atiqah Shahrizan, 24, di Lata Iskandar Kilometer 22 Jalan Tapah - Cameron Highlands pada

jam 5.33 petang 5 Jun lalu dengan kata ugutan 'pecah muka kau sat lagi'.

Berikutan itu, dia didakwa melakukan kesalahan yang boleh dihukum mengikut Seksyen 506 Kanun Keseksaan yang sabit kesalahan boleh dipenjara tujuh tahun atau denda atau kedua-duanya sekali.

Bagi pertuduhan kedua, Mohammad Zaim didakwa dengan sengaja menyebabkan kecederaan kepada mangsa di lokasi dan masa sama mengikut Seksyen 323 Kanun Keseksaan.

Sabit kesalahan, boleh dipenjara setahun atau denda hingga RM2,000 atau kedua-duanya sekali.

Minta hukuman setimpal

Pendakwaan dilakukan Timbalan Pendakwa Raya J Geetha yang meminta mahkamah menjatuhkan hukuman setimpal sebagai pengajaran kepada tertuduh dan masyarakat, manakala tertuduh tidak diwakili peguam.

Bagaimanapun, Mohammad Zaim meminta hukuman paling ringan memandangkan dia perlu menanggung seorang isteri yang hamil lapan bulan dan seorang anak ber-

usia empat tahun dengan pendapatan bulanan RM4,000.

Mahkamah kemudian menetapkan tertuduh disabitkan kedua-dua kesalahan iaitu masing-masing penjara tujuh hari yang berjalan serentak dari tarikh sabitan.

Ketika menjatuhkan hukuman, Siti Hanum berkata, setiap tindakan yang dilakukan ada kesannya, sama ada kepada diri sendiri atau keluarga dan masyarakat.

"Maka fikirkanlah dulu sebelum bertindak," katanya.

Terdahulu tular satu video berdurasi 59 saat memaparkan seorang lelaki berbaju merah keluar dari kereta PROTON Persona dipandunya dan mengetuk cermin kenderaan di belakangnya sebelum memarahi pemandu wanita serta memukul kepala mangsa.

Dalam kejadian itu, pemandu wanita terbabit turut dilemparkan kata-kata kesat oleh lelaki itu sebelum kepalanya dipukul.

Lelaki itu ditahan sepasukan polis dari Bahagian Siasatan Jenayah, Ibu Pejabat Polis Daerah (IPD) Tapah pada 5 Jun lalu, selepas mangsa membuat laporan polis di Balai Polis Saujana Utama, Sungai Buloh.

4 individu termasuk 3 pelajar didakwa

Klang: Empat lelaki termasuk tiga pelajar sekolah dihadapkan ke Mahkamah Majistret, dekat sini, semalam atas pertuduhan mencederakan seorang warga emas dipercayai gelandangan pada Mei lalu.

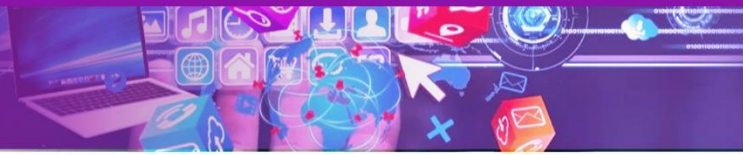

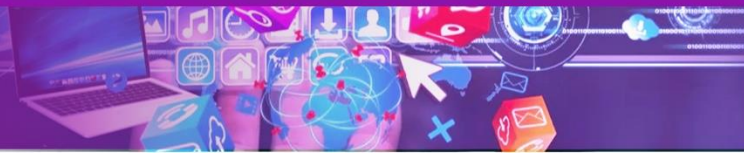

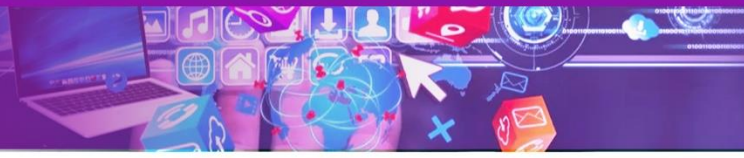

MAN WHO HIT FEMALE DRIVER JAILED 7 DAYS

Factory supervisor now being probed by Pahang cops for verbally abusing restaurant workers, slapping one of them

THE man who was filmed hurling abusive words and hitting a female driver's head was sentenced to seven days in jail by the magistrate's court here yesterday.

However, that is not the end of 29-year-old factory supervisor Mohammad Zaim Faiz Tarmizi's troubles as police in Pahang are investigating him for verbally abusing restaurant workers in Cameron Highlands and slapping one of them on June 4.

Pahang police chief Datuk Yahaya Othman said a restaurant worker had lodged a report at the Cameron Highlands police station against the man on June 7 and that police were completing their probe.

"Investigations revealed that the suspect had slapped one of

the workers repeatedly because the food he ordered arrived late and another worker was hit when he tried explaining to the suspect that the dish he ordered was not available.

"Police will call up several witnesses to complete the investigation into the incident."

Yahaya said investigations were carried out under Section 323 of the Penal Code for voluntarily causing hurt and Section 14 of the Minor Offences Act for using abusive words.

Earlier, magistrate Siti Hanum Mohamad Sah passed the sentence on Mohammad Zaim Faiz Tarmizi, 29, after he pleaded guilty to charges of voluntarily causing hurt and criminal intimidation.

For the first charge, Zaim threatened Amiera Atiqah Shahrizan, 25, by uttering "pecah muka kau sat lagi" (I will break your face).

The offence falls under Section 506 of the Penal Code for crim-

inal intimidation, which carries a jail term of up to seven years or a fine, or both, on conviction.

For the second charge, he voluntarily caused hurt to the same person under Section 323 of the Penal Code, which provides imprisonment of up to two years or a fine of up to RM2,000 or both, upon conviction.

Both offences were committed at Lata Iskandar, Km22 of Jalan Tapah-Cameron Highlands, here, at 5.33pm on June 5.

Deputy public prosecutor Geetha Jora Singh prosecuted and Zaim was unrepresented.

During mitigation, the factory supervisor, who earns RM4,000 monthly, said he had to take care of his child and wife, who is eight months' pregnant.

"I plead for a light punishment. The complainant tried to overtake (my car), but there was a car in front.

"If she did that, it could cause a fatal accident for my family and those at the back (of my car). That is why I was so mad. I had my pregnant wife and child in the car."

Geetha Jora asked the court to impose a deterrent punishment as such an act by Zaim, where he got out of his car, threatened and

hit the victim's forehead, was irrational.

"Should the court give a hefty punishment to the accused, it sends a message to people who might plan to or commit the same offence. By giving a light punishment, such offences will be taken lightly by others."

Before handing down the sentence, Siti Hanum said every action had consequences for the person, their family and the people.

"The court is the last bastion of justice for all people. Punishment should be a lesson for all. Think before you act. Think about your family first."

The court sentenced Zaim to seven days in jail, with the sentence commencing yesterday.

It was reported that police detained a man who was filmed hurling abusive words and hitting a female driver's head in a video that went viral.

In the 59-second video posted by Facebook user Aizacd Zack, a man clad in a red T-shirt is seen getting out of his car, knocking on the driver's window and berating the female driver over her driving.

The woman tries to explain, but he continues hurling abusive words at her. He then hits her on the head more than once.

Perak police chief Datuk Seri Mohd Yusri Hassan Basri said the woman lodged a report at the Saujana Utama police station in Sungai Buloh, Selangor, at 10am on Tuesday.

Someone else's MyKad also found on man who allegedly abused girlfriend's baby girl, say cops

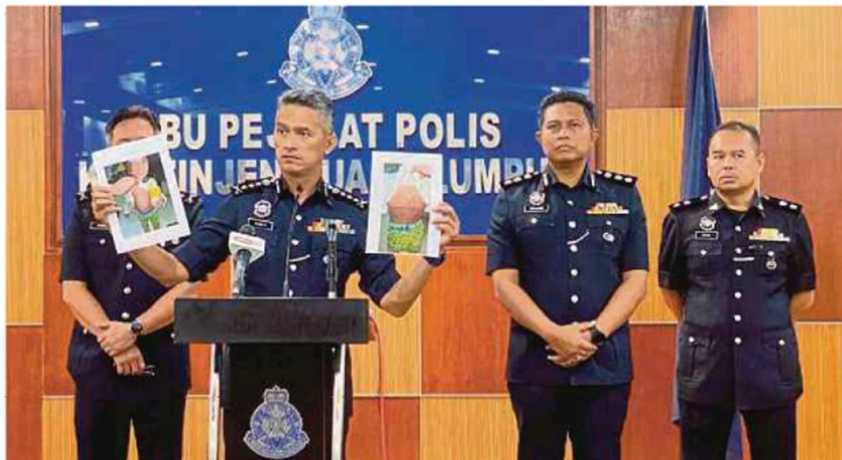

THE man who was arrested on Thursday for allegedly abusing his girlfriend's baby girl has a long criminal record.

Kuala Lumpur police chief Datuk Mohd Shuhaily Mohd Zin said a urine test on the 31-year-old also showed that he was positive for drugs.

He confirmed that the man has a criminal and drug history.

"We have obtained a seven-day remand order from today until

June 15. "Investigations are being conducted under section 31 (1)(a) of the Child Act 2001, section 15 (1) of

the Dangerous Drugs Act 1952 and Regulation 25 of the National Registration Act as someone else's identity card was in his posses-

sion," Shuhaily told a press conference at the city police headquarters here yesterday.

He said the investigation also re-

vealed that the suspect, who is unemployed, had known the baby girl's mother and lived with her for the past two months at the Desa Rejang People's Housing Project in Setapak here.

"The abuse is believed to have happened because the baby was active and this allegedly led to the actions committed by the suspect."

Wangsa Maju district deputy police chief, Deputy Superintendent D. Saralathan, had previously said that the suspect was arrested at an apartment in Jinjang, Sentul on Thursday.

The man had allegedly beaten the victim until her lips were swollen and both eyes and back were bruised.

She was sent to Kuala Lumpur Hospital for examination and further treatment. Investigations were conducted by the Sexual, Women and Children's Investigations Division of the Kuala Lumpur police headquarters.

A video of a 23-month-old baby girl had gone viral on social media.

Hurting wife: Actor Hafidz Roshdi fit to stand trial

KUALA KUBU BHARU: A magistrates' court here was told yesterday that actor Hafidz Roshdi, who was charged with injuring his wife in March, is fit to stand trial.

Deputy public prosecutor, Asmaa' Zamri said this was based on psychiatric evaluation reports issued by Hospital Bahagia Tanjung Rambutan, Perak, on Hafidz Roshdi, whose real name is Muhammad Hafidz Roshdi, 29.

"The prosecution has received the psychiatric evaluation report, which states that the accused is fit and can be tried by this court," he said during the mention of the case before Judge Mohd Kaffi Che Ali, who acted as Magistrate.

Asmaa' also applied to the court for another date to be fixed for the submission of documents.

Lawyer Datuk Akberdin Abdul Kader, who represented Muhammad Hafidz, requested that a copy of the psychiatric report be submitted to the defence, but Asmaa said the prosecution only had one copy of the report and it would be submitted at the next mention of the case.

In the previous proceedings, the court ordered that the actor get a psychiatric examination and treatment after the prosecution requested that the accused be referred to Hospital Bahagia Tanjung Rambutan, Perak in accordance with Section 342 of the Criminal Procedure Code.

On March 13, Muhammad Hafidz pleaded not guilty to the

charge of intentionally causing injury to his wife, Nurul Shuhada Mat Shukri, 29, by punching her left cheek three times until the victim suffered cuts, bruises and swelling.

The actor of the drama series 'Tundukkan Playboy Itu', was

accused of committing the offence near the Sungai Buaya Toll exit, here at 3.22 am, on March 2.

The charge, framed under Section 323 of the Penal Code, carries a maximum jail term of one year, or a fine of up to

RM2,000, or both if convicted. The charge was read together with Section 326A of the same law, which carries imprisonment for a term which may extend to twice the maximum term on conviction under Section 323. — Bernama

Meanwhile in her speech, KFA Women chief Tiong Kiu Lan highlighted the importance of filial piety.

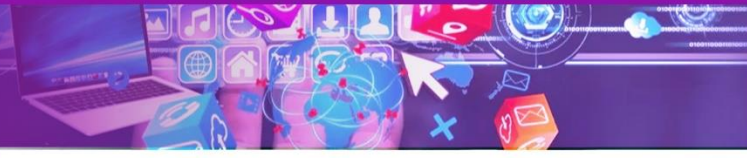
"Looking after our parents, especially during their golden years, is the children's responsibility.

KPWKM plans to establish database for registered babysitters — Nancy

PUTRAJAYA: The Women, Family and Community Development Ministry (KPWKM) will establish a database of the list of registered babysitters to help parents to choose daycare centres and registered babysitters for their children.

Its minister Datuk Seri Nancy Shukri said that at the moment, there is no platform or referral centre for parents to choose their desired nanny.

"As of now, we do not have any centralised data. When people send their children to a daycare centre, there is no indication, only word of mouth.

"These parents want to know where the daycare is and who is running it," she told reporters after opening the 2023 National Congress on Childcare and Early Education here yesterday.

Without saying when the database might be realised, Nancy said the effort is still in the planning stage.

Meanwhile, she said the ministry will hold 105 engagement sessions with local authorities (PBT) nationwide this year to find a solution to facilitate the registration of babysitters interested in running nurseries.

According to Nancy, she often receives complaints from entrepreneurs who want to operate legally and be registered but face bureaucratic and technical problems from PBT.

She said she will discuss with the Local Government Development Minister Nga Kor Ming on how to make it easier for nursery operators to operate

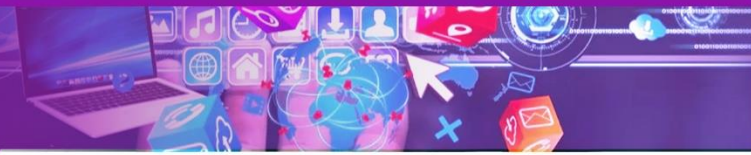
legally without compromising on safety.

At the ministry level, Nancy said it only takes 30 days to get approval to register a nursery, but operators must first meet the safety conditions set by the PBT.

"Conditions that must be met are the location of the nursery, such as the distance from the main road, nursery must not be

more than one-storey, and there is a need for a security door. These conditions are a challenge for nursery operators when registering (their premises)," she said.

As of December last year, it was found that a total of 1,080 nurseries were not registered with the Social Welfare Department (JKM). — Bernama

KPWKM views seriously viral child abuse case in PPR Desa Rejang

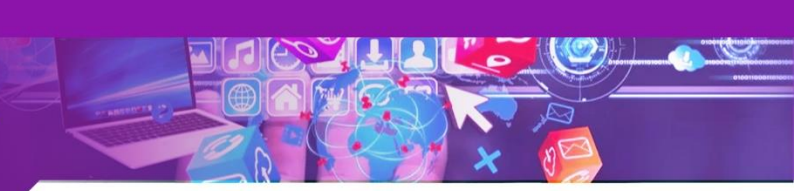

Man gets seven days' jail for assaulting female driver

TAPAH: The Tapah Magistrates' Court yesterday sentenced a man who assaulted a female driver in an incident in Lata Iskandar, which went viral last Monday, to seven days in prison.

Magistrate Siti Hanum Mohamad Sah meted out the sentence after Mohammad Zaim Faiz Tarmizi, 29, who was unrepresented, pleaded guilty to the two charges against him.

He was charged under Section 506 of the Penal Code for criminal intimidation and Section 323 of the Penal Code for voluntary causing hurt.

The accused could be sentenced to imprisonment for up to seven years, or a fine or both for the first offence, and imprisonment for up to one year or a fine of up to RM2,000 or both for the second offence.

Mohammad Faiz was later sentenced to seven days in prison on each count and the sentences to run concurrently from the

date of conviction which is yesterday.

According to the facts of the case, in the 5.33pm incident on June 5, the complainant Amiera Atiqah Shahrizan, 24, was with her brother travelling in a Myvi car on their way to Cameron Highlands.

The complainant admitted that she tried to overtake a Persona car driven by the accused.

On reaching Lata Iskandar, KM 22 Jalan Tapah - Cameron Highlands, the accused got out of his car, knocked the window of the complainant's car and started scolding and threatening her by saying "I am going to break your face soon" and proceeded to hit her on the forehead.

The complainant then lodged a police report and was referred to Tapah Hospital, where she was found to have a soft tissue injury on the face.

Earlier, deputy public prosecutor JS Gheeta urged that

a sufficient sentence be imposed on the accused for berating, threatening and hitting the victim on the forehead which was unbecoming and irrational.

Mohamad Zaim Faiz, however, appealed for a lighter sentence as he has a child and a pregnant wife to support adding that he acted in such a way as he was angered by the woman's reckless way of driving.

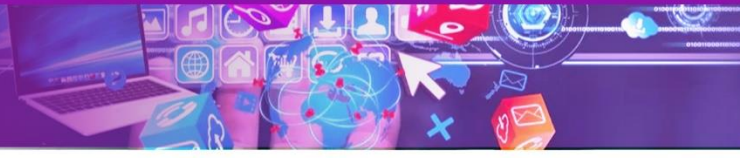
Meanwhile, Siti Hanum in advising the accused to think before acting, said any action taken would not only affect oneself, but also one's family and the community.

"The case has already gone viral, the court needs to make decisions accordingly," she said.

According to the facts of the case, in the 5.33pm incident on June 5 - a video of which has since gone viral - the complainant Amiera Atiqah Shahrizan, 24, was with her brother travelling in a car on their way to Cameron Highlands.

The complainant admitted that she tried to overtake the car driven by the accused.

On reaching Lata Iskandar, KM22 Jalan Tapah-Cameron Highlands, the accused got out of his car, knocked the window of the complainant's car and started scolding and threatening her by saying "I am going to break your face soon" and proceeded to hit her on the forehead.

The complainant then lodged a police report and was referred to

Hospital Tapah, where she was found to have soft tissue injury on the face, Bernama reported.

Earlier, deputy public prosecutor JS Gheeta urged that a sufficient sentence be imposed on the accused for berating, threatening and hitting the victim on the forehead which was unbecoming and irrational.

Mohamad Zaim, however,

appealed for a lighter sentence as he has a child and a pregnant wife to support, adding that he acted in such a way because he was angered by the woman's reckless way of driving.

Meanwhile, Siti Hanum in advising Mohamad Zaim said one must think before acting, adding that any action taken would not only affect one's self, but also

one's family and the community.

"The case has already gone viral, the court needs to make decisions accordingly," Siti Hanum added.

A 59-second video showing a man assaulting a female motorist went viral on social media on Monday, which led to the Mohamad Zaim's arrest in Serdang, Selangor on Tuesday.

Man who killed lover fails in bid to end his life

PETALING JAYA: A foreigner failed in his bid to end his life after brutally murdering his lover when he lay on the “wrong track” of the Express Rail Link (ERL) near Salak Selatan, said the police.

Petaling Jaya OCPD Asst Comm Mohamad Fakhruddin Abdul Hamid said the man could only watch the train pass by in the next track before he was caught by auxiliary police.

The police, he said, were alerted about the incident at around 4.50pm on June 3

after the man was nabbed near the Bandar Tasik Selatan ERL station.

The auxiliary police then handed over the 30-year-old suspect to the Cheras police, he added.

“It was during interrogation that the man confessed to killing his 40-year-old lover at a condominium in Kelana Jaya,” he told reporters yesterday.

He did not reveal the duo’s nationality.

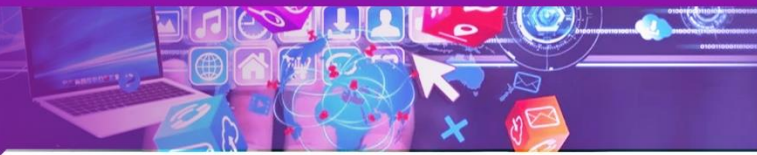
ACP Mohamad Fakhruddin said the suspect then led Cheras and Petaling Jaya

police to the condominium unit where police found six men and a woman living there.

“The suspect then took police to a room where his girlfriend, also a foreigner, stayed. She was found lying motionless covered in blood, with a knife near the scene,” he said.

He said the suspect was believed to have stabbed the woman at least 18 times and slit her throat between 4pm and 6pm on June 2.

The motive is believed to be jealousy.

National database of registered babysitters to be set up

PUTRAJAYA: The Women, Family and Community Development Ministry will establish a database of registered babysitters to help parents choose daycare centres and carers for their children.

Minister Datuk Seri Nancy Shukri said currently there is no platform or referral centre for parents to choose babysitters.

"As of now, we do not have any centralised data. When people send their children to a daycare centre, there is no indication, only word of mouth.

"These parents want to know where the daycare is and who is running it," she told Bernama after opening the 2023 National Congress on Childcare and Early Education here yesterday.

"The move to build the database is still at the planning stage."

Meanwhile, her ministry will hold 105 engagement sessions with local authorities nationwide this year to find a solution to facilitate the registration of babysitters interested in running nurseries.

Nancy said she often received complaints from entrepreneurs who want to operate legally and be registered, but they said they face bureaucratic and technical problems from local authorities.

She will talk to Local Government Development Minister Nga Kor Ming on how to make it easier for nursery operators to operate legally without compromising safety.

At the ministry level, Nancy said it only takes 30 days to get approval to register a

nursery, but operators must first meet the safety conditions set by local authorities.

"Conditions that must be met are the location of the nursery, such as the distance from the main road, it must not be more than one storey, and there is a need for a security door. These conditions are a challenge for nursery operators when registering," she said.

As of December last year, it was found that 1,080 nurseries were not registered with the Social Welfare Department.

MUAR: Two men have been charged with raping a 14-year-old girl in Parit Jawa here.

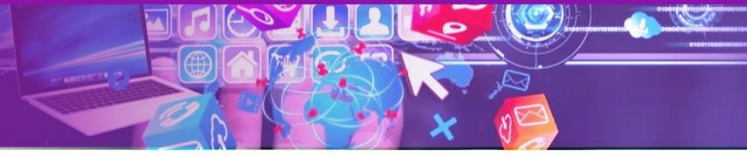
Muar OCPD Asst Comm Raiz Mukhliz Azman Aziz said the teenager knew one of the suspects while the other man was the suspect's friend.

Woman conned of RM1.6mil

Kindergarten owner falls victim to online investment scam

MELAKA: A kindergarten owner has lost RM1.6mil in an investment scam supposedly run by a "Taiwanese businessman".

To make matters worse, the 53-year-old victim from Ayer Keroh here had also borrowed money from her family members to invest in the so-called business.

Melaka police chief Deputy Comm Zainol Samah said the woman found out about the businessman over the Internet back

in April.

"The fraudster who introduced himself as 'Tan Sau Fung' claimed he was residing in Japan. He persuaded the woman to invest in a United States-run online shopping mall," he said.

DCP Zainol said the investment scheme would require the woman to make purchases from the online shopping mall and Tan would later resell the products to a third party.

The woman in turn would be paid 10% of the sales value.

Subsequently, she checked a website which notified her that she would be getting a commission of about RM923,000, DCP Zainol said.

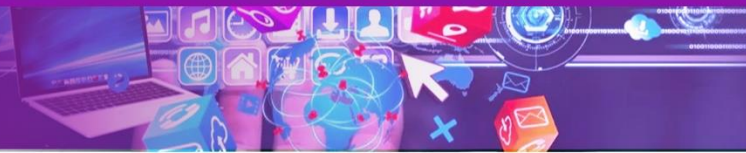
The commission was promised to her after the woman had deposited money into bank accounts provided by the conman through 28 transactions between May 7 and May 30.

But on May 31, the woman discovered that the website had been shut down when she tried to access it.

She lodged a police report on the same day at Ayer Keroh police station.

DCP Zainol said preliminary investigation revealed that the money was deposited into six mule bank accounts.

Police are tracking the conman and his accomplices, he added.

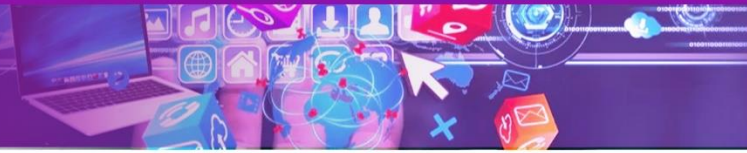

"Selama ini kita masih belum ada data yang secara berpusat, jadi kalau orang hantar anak dia ke taska, tiada tempat rujukan cuma melalui diberitahu orang lain."

"Ibu bapa ini dia nak lihat lokasi yang bersesuaian dan siapa yang menjalankan tempat pengasuhan itu," katanya dalam sidang media selepas merasmikan Konvensyen Pengasuhan dan Pendidikan Awal Kanak-Kanak Kebang-

saan 2023, di sini semalam.

Tanpa menyatakan bila pangkalan data itu dapat direalisasikan, Nancy berkata usaha berkenaan mengambil masa yang lama dan ia masih di peringkat perancangan.

Dalam pada itu, beliau berkata KPWKM akan mengadakan 105 sesi latihan ini bersama pihak berkuasa tempatan (PBT) di seluruh negara bagi mencari penyelesaian untuk memudahkan pendaftaran pengasuh yang berminat menjalankan operasi Taman Asuhan Kanak-Kanak (Taska).

Menurut Nancy, beliau sering mendapat rungutan daripada pengasuh yang mahu beroperasi secara sah namun menghadapi kerenah birokrasi membabitkan isu teknikal di pihak PBT.

"Kita tahu ini adalah kuasa PBT tetapi saya rasa ini boleh ditambah baik, sebagai contoh, sekiranya semua PBT mempunyai budi bicara dan peraturan yang selaras," katanya.

Bagi pertuduhan pertama, Mohamad Zaim Faiz didakwa menakutkan secara jenayah terhadap mangsa dengan kata ugutan “pecah muka kau sat lagi” di Lata Iskandar Kilometer 22 Jalan Tapah-Cameron Highlands pada jam 5.33 petang 5 Jun lalu.

Penyelia mesin itu didakwa mengikut Seksyen 506 Kanun Keseksaan yang sabit kesalahan boleh dipenjarakan tujuh tahun atau denda atau kedua-duanya sekali.

Bagi pertuduhan kedua, tertuduh didakwa dengan sengaja menyebabkan kecederaan kepada mangsa di lokasi dan masa sama.

Dia didakwa mengikut

Seksyen 323 Kanun Keseksaan yang sabit kesalahan boleh dipenjarakan setahun atau denda hingga RM2,000 atau kedua-duanya jika sabit kesalahan.

Terdahulu, Timbalan Pendakwa Raya JS Geetha memohon hukuman setimpal dijatuhkan ke atas tertuduh kerana perbuatan tertuduh memaki hamun, mengugut dan menampar dahi mangsa adalah tidak wajar dan tidak rasional.

“Ia juga bagi memberi mesej kepada masyarakat di luar sana supaya jangan mengambil tindakan sewenang-wenangnya dan mengambil pengajaran daripada kes ini,” katanya.

Mohamad Zaim Faiz bagaimanapun merayu hukuman paling ringan kerana mempunyai seorang anak dan isteri yang sedang sarat mengandung.

Mohamad Zaim Faiz memberi alasan tindakannya itu kerana terlalu marah akibat nyawanya dan keluarga terancam kerana tindakan pemanduan wanita berkeanaan.

Siti Hanum bagaimanapun menasihatkan tertuduh supaya selepas ini berfikir sebelum bertindak.

“Kerana setiap tindakan bukan hanya memberi kesan kepada diri sendiri sahaja, tetapi juga kepada keluarga dan masyarakat. Kes sudah pun tular, mahkamah perlu membuat keputusan sewajarnya,” katanya.

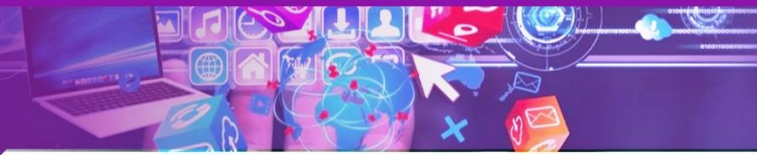

"Sejak berkenalan, pengadu sering berhubung dengan suspek melalui talian LINE dan berkomunikasi secara lisan serta SMS sebelum hubungan mereka menjadi rapat dalam tempoh yang singkat.

"Pada 7 Mei lepas, suspek telah menawarkan mangsa supaya melabur dengan membeli barang yang kononnya dari Amerika Syarikat menerusi laman sesawang <https://everythingmallx.cc/>," katanya dalam kenyataan semalam.

Beliau berkata, mangsa dikehendaki membeli dahulu barang yang hendak dibeli

pelanggan sebelum menjual semula untuk mendapat keuntungan sebanyak 10 peratus bagi setiap barang tersebut.

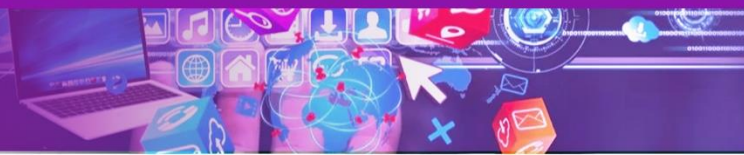
Zainol berkata, akibat terlalu mempercayai suspek, wanita berkenaan telah melakukan 28 transaksi bayaran secara berperingkat ke dalam enam akaun berbeza berjumlah RM1.06 juta dalam tempoh 7 hingga 30 Mei lepas.

Beliau berkata, pada 30 Mei lepas juga, mangsa telah menyemak komisen yang diperolehnya di laman sesawang berkenaan mencecah

jumlah US\$200,000, namun dia mula curiga dan sedar ditipu apabila diarah membuat bayaran tambahan bagi mengeluarkan komisen tersebut.

Menurut Zainol pada keesokan hari, mangsa cuba mengakses laman sesawang berkenaan namun tidak boleh diakses dan akaun Instagram suspek juga telah ditutup.

"Justeru, mangsa membuat laporan di Balai Polis Ayer Keroh pada Rabu dan kes disiasat di bawah Seksyen 420 Kanun Keseksaan kerana menipu," katanya. — Bernama

“Ujian saringan air kencing juga mendapati suspek positif dadah jenis Amphetamine dan Methamphetamine serta direman tujuh hari bermula hari ini (semalam) bagi membantu siasatan,” katanya.

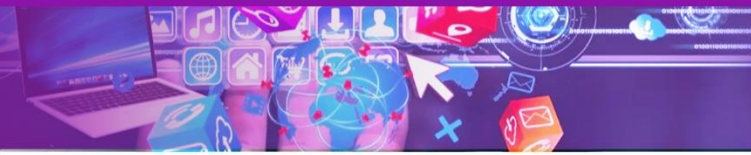

“Ketika sampai di rumah pengadu, pasukan bomba dimaklumkan oleh penghuninya berlaku kebakaran peralatan perkakas memasak di dapurnya.

“Namun, kebakaran itu berjaya dipadamkan oleh penghuni rumah terbabit iaitu seorang wanita berusia 30 tahun menggunakan teknik menutupi sepenuhnya dapur terbakar dengan kain basah,” katanya di sini semalam.

Seramai lapan orang anggota bomba dikerahkan ke lokasi itu.

Menurut Mahmudin, tiada

operasi pemadaman dilakukan oleh pasukan bomba dalam kejadian itu.

“Bomba hanya membuat pemeriksaan dan seterusnya menjalankan siasatan terhadap punca kebakaran itu.

“Setelah selesai dan memastikan keadaan selamat serta tidak berlaku kebakaran berulang, pasukan bomba bertolak balik ke balai,” jelasnya.
