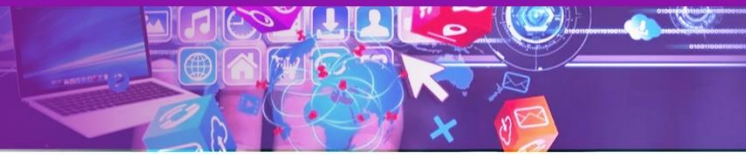

'Proposed carnival can boost women's participation in entrepreneurship'

KUCHING: The proposed Entrepreneur and Women Cooperatives Carnival and Convention can help increase women's participation in entrepreneurship, said Minister of Women, Childhood and Community Wellbeing Development Dato Sri Fatimah Abdullah.

The event is to be held in Miri and is organised by Dewanita, which is the Women's branch of Sarawak Bumiputera Entrepreneurs Chamber (DUBS) Miri, together with Angkatan Kebangsaan Malaysia Berhad (Angkasa) Miri.

Fatimah said it was in line with the aspirations of the Sarawak Women and Family Department in empowering women.

"This programme will not only empower them for their families but also for the whole community," she said after a courtesy call by DUBS Miri, Dewanita and Angkasa Miri on Tuesday.

The courtesy call was to brief Fatimah on the convention which will be held in conjunction with the Hari Wanita Desa Antarabangsa 2023 celebration.

She said with such a programme organised by

Dewanita and Angkasa, it will be a strategic collaboration as both sides can help each other in terms of empowering women.

Miri with some of them becoming global players," she said.

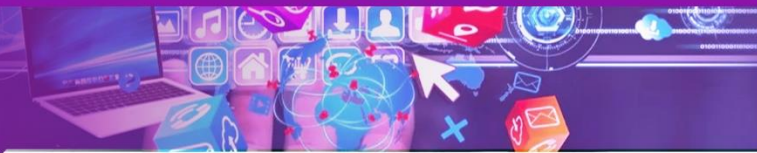

Hardcore poor, PwD can apply for lower land premiums — Perak MB

IPOH: Eligible individuals under the category of hardcore poor or persons with disabilities (PwD) in Perak can apply for lower land premium payments.

Menteri Besar Datuk Seri Saarani Mohamad said that the Premium Reduction Appeal Application Policy was based on the recommendation of the State Land and Mines Director's Office (PTG) and is to be decided by the state authority.

"The state government understands and is always concerned about the poor and less privileged (who may struggle) to afford a high land premium rate.

"Therefore, the Perak PTG has issued the Director of Land and Mines Circular No.3/2020 regarding the Premium Reduction Appeal Application Policy," he said during the question and answer session at the State Legislative Assembly sitting yesterday.

He was responding to a question from Ong Boon Piow (PH-Bercham) who wanted to know whether the state government would offer instalment payments so that the poor could afford to pay the high premium even after being granted a discount.

Saarani said the installment payment method was not implemented as these payments were considered as 'one-off' to allow the registration of ownership, and the payment period was set for three months

from the date of issuance of Notice 5A, which can be extended for another three months.

"The details of Notice 5A for the purpose of premium payments include the First-Year Tax, Survey Fee, Boundary Marking Fee and ownership registration fee. Failure to complete the payment of Notice 5A within the stipulated period can result in the expiration of ownership approval by the state authority," he said.

He said the state government also understands the people's concerns regarding the long waiting period for land ownership approval processes, title renewals, land ownership change approvals and so on.

Therefore, he said that the PTG has made improvements to the development processes, such as simultaneous applications for sub-division and variation of conditions (Section 124A), surrender and re-alienation (Section 204A-H) and sub-division (Section 136) (of the National Land Code).

"The state government has also delegated powers from the state authority to the Land and Mines director and Land Administrator for specific matters. These improvements have shortened the application processing time to between 20 and 30 days compared to longer processing time in the past," he said. — Bernama

Man jailed for threatening to hit mum over refusal to give him RM80

KUCHING: A man who threatened to strike his mother after she refused to give him money was sentenced to one year and two months in prison by the Magistrates' Court here yesterday.

Muhd Nur Ikmal Juhari, 27, pleaded guilty before magistrate Nursyaheeqa Nazwa Radzali to a charge of committing criminal intimidation, framed under Section 506 of the Penal Code.

He also pleaded guilty to a second charge of committing mischief, framed under Section 427 of the Penal Code, and was sentenced to one year in prison.

The court ordered the sentences to run concurrently from the date

of his arrest on Sept 25, 2023.

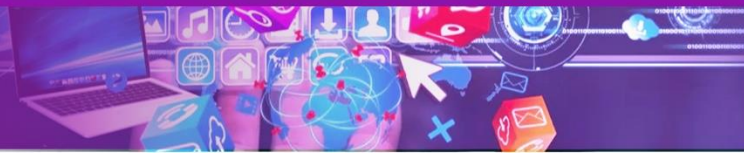
Muhd Nur Ikmal committed the offences at around 7pm at a house in Kampung Boyan, Petra Jaya here.

Based on the facts of the case, he threatened to hit his 60-year-old mother if she did not give him RM80.

He had earlier damaged the door of his mother's bedroom by kicking it until it came off its hinges.

Fearing for her safety, his mother contacted the police for help and Muhd Nur Ikmal was arrested later that same night.

Insp Merylene Lindan Andrew Mang prosecuted, while the accused was unrepresented.

Police nab priest from India over sexual assault

KUALA LUMPUR: Police arrested a priest who is believed to have sexually assaulted a local woman in early 2017.

Acting Serdang police chief Supt Izuddin Ab Wahab said the suspect from India was arrested in Puchong Jaya, Selangor on Sept 23.

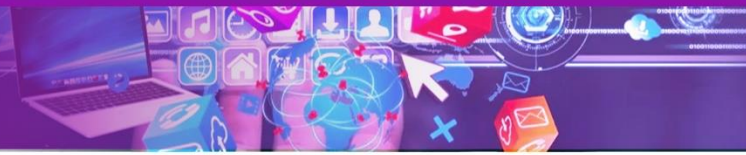
The suspect is under remand until Sept 30 to assist investigation under Section 376 of the Penal Code, he added.

"Thus far, only one victim has lodged a police report involving the suspect," he said in a statement yesterday.

It was previously reported that the man, in his 40s, was being tracked down by police after the victim, in her 30s, filed a report about an incident which occurred about six years ago.

The alleged incident occurred in Puchong, Selangor inside the victim's vehicle. At the time, she had just gotten to know the suspect following a religious ceremony.

The victim only reported the incident last month after experiencing trauma.

Single mother, S'porean friend plead guilty to abusing son

JOHOR BAHRU: A single mother and her female friend pleaded guilty in the Sessions Court here yesterday to charges of abusing and neglecting her seven-year-old son.

The 27-year-old mother and her Singaporean friend Awiin Chua, 30, changed their pleas to guilty when the case was mentioned.

Judge VM Mabel Sheela then fixed Oct 10 to hear the facts of the case before sentencing.

The single mother and Awiin were jointly charged with abusing and neglecting the boy, causing the victim to suffer physical injuries, at a house in Pasir Gudang between July 1 and Aug 9 this year.

They were charged under Section 31(1)(a) of the Child Act 2001 read together with Section 34 of the Penal Code, and face a maximum fine of RM50,000 or imprisonment of not more than 20 years or both.

Deputy public prosecutor

Nur Diyana Zubir appeared for the prosecution, while lawyer Abd Rahim Ali represented both accused.

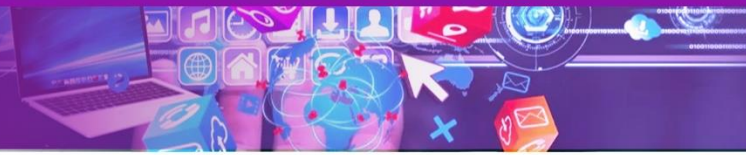
The court also maintained the mother's bail of RM15,000 in one surety for all charges, and Awiin's bail of RM20,000 in one surety for all charges.

They were also ordered to report themselves at a police

station once a month pending the disposal of their case and to not intimidate the victim.

On Aug 16, both accused claimed trial to the charge of abusing and neglecting the boy.

Abd Rahim, when met by reporters outside the court, said that until now, family members or acquaintances of both accused did not post bail.

Foreign monk detained for alleged sexual assault

SERDANG: A foreign monk has been detained for alleged sexual assault in Puchong.

Serdang acting OCPD Supt Izuddin Ab Wahab said the suspect, in his 40s, was detained in Puchong on Sept 23.

"He has been remanded for seven days until Sept 30.

"We are investigating the mat-

ter further," he said when contacted.

Supt Izuddin said a victim, a woman in her 30s, came forward to lodge a police report against the suspect last month.

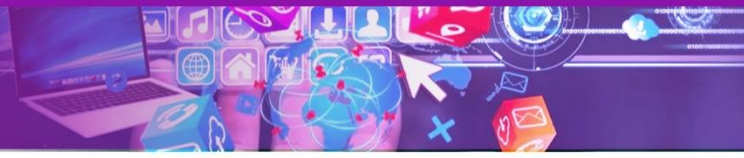
"She alleged that the incident occurred in Puchong six years ago, where she was sexually assaulted in her car," he said.

The woman's statement has been recorded to assist in the investigation, he said, adding that police were also seeking witnesses for the case classified under Section 376 of the Penal Code for rape, which carries a jail term of between five and 20 years, and whipping, upon conviction.

When contacted, Bukit Aman

Sexual, Women and Child Investigations Division (D11) assistant director Asst Comm Siti Kamsiah Hassan said should the investigation require it, the victim might be asked for additional statements.

"This is our procedure, and if needed, of course the police will call her back," she said.

Poor, disabled to pay lower land premium fees

IPOH: The hardcore poor and disabled in Perak can apply to pay lower land premium fees, says Datuk Seri Saarani Mohamad.

The Menteri Besar said the Land and Mines Office (PTG) director would review applications before approval by the state.

"We understand the difficulties and hardship faced by these groups especially when it comes to paying the land premium fees.

"Therefore, PTG has issued the 2020 Perak Land and Mines office director circular Bil 3 (Pekeliling Pengarah Tanah Dan Galian Negeri Perak Bil 3 tahun 2020) under the Premium Reduction Appeal Application Policy where individuals under these groups can apply for lower premium fees," he said when answering to Ong Boon Piow (PH-Bercham) during the question-answer session at the Perak assembly sitting here yesterday.

Earlier, Ong asked if the state had plans to allow the hardcore poor to pay the land premium in

instalments over two to five years.

Saarani (BN-Kota Tampan) said the method was not being implemented as the fee was a one-off

payment to allow ownership to be registered.

"The administration also understands the issue raised on the long

waiting period for the approval process of land grantor, grant renewal, permission to change land ownership and others.

"PTG, which is responsible for such matters, will be improving their services from time to time. They have issued several circulars on such related matters mentioned which will cut short the waiting period by between 20 and 30 days compared to the previous system.

"While the e-Tanah system is being used, there are several parts that require PTG to conduct research before we can grant the approval. There are several procedures that need to be done and that could take time.

"Applications such as changing of property ownership between a bumiputra and bumiputra or bumiputra and non-bumiputra may sound direct, but there are moratorium periods and requirements that need to be checked before it can be approved," he added.

Dua lelaki termasuk warga emas didenda RM800, seminggu penjara

MIRI: Dua lelaki termasuk seorang warga emas masing-masing didenda RM800 atau seminggu penjara oleh Mahkamah Majistret di sini setelah mengaku bersalah atas tuduhan bermain judi di tempat awam.

Sawal Timbang, 56, dari Bandar Baru Permyjaya dan Tsen Fang Lung, 37, dari Gilbert Estate di sini telah didakwa mengikut Seksyen 7 (2) Akta Rumah Judi Terbuka 1953 yang memperuntukkan denda tidak melebihi RM5,000 atau penjara enam bulan atau kedua-duanya jika sabit kesalahan.

Menurut keterangan kes, Sawal ditahan jam 7.30 malam, pada 24 September lalu di hadapan sebuah restoran Jalan Pelita 2, Pusat Komersil Pelita di sini manakala Tsen ditahan jam 6 petang, pada 21 September lalu di kaki lima hadapan sebuah lot, Jalan Teo Chew di sini.

Penahanan ke atas mereka dilakukan untuk tujuan pemeriksaan kerana disyaki terlibat aktiviti perjudian jenis judi dalam talian (online) di tempat awam.

Pemeriksaan lanjut ke atas telefon pintar milik kedua-dua tertuduh mendapati memaparkan aplikasi judi dalam talian.

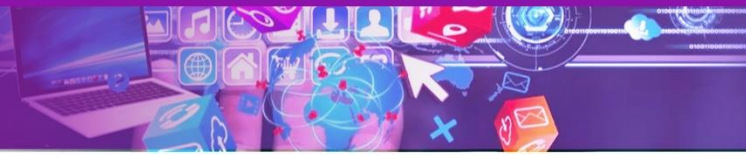
Berikutan itu, kedua-dua tertuduh ditangkap dan telefon bimbit mereka dirampas untuk dijadikan barang kes.

Pertuduhan kes dibacakan secara berasingan kepada kedua-dua tertuduh.

Di hadapan mahkamah, pegawai pendakwa turut mengemukakan beberapa bahan bukti termasuk telefon bimbit dan juga laporan pakar judi.

Ketika rayuan, kedua-dua tertuduh masing-masing merayu agar hukuman ke atas mereka diringankan memandangkan ini adalah kesalahan pertama mereka.

Pendakwaan dilakukan ASP Mary Ong di hadapan Majistret Nazira Adlin Ahmad Khairul Razi, manakala kedua-dua tertuduh tidak diwakili peguam bela.

Ibu tunggal, rakan mengaku salah aniaya dan abai anak

JOHOR BAHRU: Seorang ibu tunggal dan rakan wanitanya mengaku bersalah di Mahkamah Sesyen di sini semalam atas pertuduhan menganiaya dan mengabaikan anak lelakinya berumur tujuh tahun di Pasir Gudang di sini.

Wanita itu yang berumur, 27, dan rakannya warga Singapura berumur, 30, menukar pengakuan kepada bersalah, ketika sebutan kes berkenaan semalam.

Hakim VM Mabel Sheela kemudian menetapkan 10 Okt untuk mendengar fakta kes, sebelum menjatuhkan hukuman terhadap kedua-dua mereka.

Bagi pertuduhan pertama mereka didakwa dengan niat bersama menganiaya kanak-kanak berkenaan yang berada di bawah jagaan mereka sehingga menyebabkan mangsa mengalami kecederaan fizikal.

Pertuduhan kedua pula, kedua-dua wanita itu yang masing-masing seorang suri rumah dan juruteknik di sebuah kilang itu didakwa dengan niat bersama mengabaikan kanak-kanak berkenaan yang di bawah penjagaan mereka.

Kedua-dua perbuatan itu didakwa dilakukan di sebuah rumah di Bandar Layang Kasa, Pasir Gudang antara 1 Julai hingga 9 Ogos lepas.

Pertuduhan mengikut Seksyen 31(1)(a) Akta Kanak-Kanak 2001 dan boleh dihu-

kum di bawah Seksyen sama dan dibaca bersama Seksyen 34 Kanun Keseksaan yang membawa hukuman denda tidak lebih RM50,000 atau penjara maksimum 20 tahun atau kedua-duanya, jika sabit kesalahan.

Pendakwa dikendalikan Timbalan Pendakwa Raya Nur Diyana Zubir manakala peguam Abd Rahim Ali mewakili kedua-dua tertuduh.

Mahkamah turut mengekalkan ikat jamin suri rumah itu sebanyak RM15,000 bagi kesemua pertuduhan dengan seorang penjamin, dan ikat jamin juruteknik itu iaitu RM20,000 bagi kesemua pertuduhan dengan seorang penjamin warga tempatan.

Mahkamah juga mengekalkan syarat tambahan dengan kedua-dua wanita terbabit perlu melapor diri di balai polis berhampiran sebulan sekali sehingga kes selesai dan diberi amaran supaya tidak boleh mengganggu mangsa.

Pada 16 Ogos lepas, kedua-dua wanita itu mengaku tidak bersalah atas pertuduhan menganiaya dan mengabaikan kanak-kanak lelaki itu.

Abd Rahim ketika ditemui pemberita di luar mahkamah berkata sehingga kini ahli keluarga atau kenalan bagi kedua-dua anak guamnya tidak membayar wang jaminan sejak mereka dituduh. — Bernama

Lelaki mengaku tidak bersalah cederakan isteri

Seksyen 323 memperuntukkan hukuman penjara setahun atau denda RM2,000 atau kedua-duanya. Manakala Seksyen 326A memperuntukkan hukuman dua kali ganda tempoh penjara maksimum ditetapkan dalam seksyen berkaitan (323), jika sabit kesalahan.

Di hadapan mahkamah, pegawai pendakwa ASP

Mary Ong memohon ditetapkan satu tarikh baharu untuk pengurusan kes memandangkan tertuduh mengaku tidak bersalah.

Majistret Nazira Adlin Ahmad Khairul Razi membenarkan permohonan itu dan menetapkan 31 Oktober depan sebagai tarikh pengurusan kes.

Manakala tertuduh diperingatkan dibebaskan dengan jaminan tunai RM2,500 berserta seorang penjamin tempatan sementara menunggu tarikh tersebut.
